Also, despite our best efforts to keep every pet safe sometimes injuries can occur. These may include, broken nails, scrotal rashes, sore feet, abrasions and small cuts. If our staff identifies behaviors that we are concerned may cause an injury you will be notified and we will consult with our vet to get appropriate medications for your pet that can help with these behaviors. If, however, there is an incidence of injury or your pet contracts a respiratory infection, White Knoll Veterinary Hospital and Pet Resort LLC is not responsible for the cost of treatment.**

***** If a minor medical issue or a life-threatening situation should arise, I authorize White Knoll Veterinary Hospital to administer medical care or treatment that is deemed necessary. I understand this could include transporting my pet to a local emergency clinic, and I will be responsible for all related charges.*****
